## **DID SYDNEY GAS JUST MAKE A MISTAKE IN ITS REVIEW OF ENVIRONMENTAL FACTORS (REF) FOR THE SEISMIC ACQUISITION SURVEY?**

Sydney Gas is required to prepare and lodge, with the Department, a Review of Environmental Factors (REF) when they apply for approval for exploration. That REF is used by the Department to decide whether or not approval should be granted.

Of course we know in the two REFs lodged to date that Sydney Gas claims that it has had proper community consultation, and we know that's not right.

But in the Sydney Gas REF for the seismic acquisition, you don't have to look too far into it before you find the first "mistake". Well, was it a mistake? Make up your own mind.

This is a photograph which Sydney Gas put in its Review of Environmental Factors, as lodged with the Department, showing the seismic acquisition vehicles:



This is a photograph of the vehicles which were actually used in the Sydney Gas seismic acquisition survey.



It's no wonder that significant damage was occasioned to our local roads. Singleton Council is now debating the Sydney Gas damage.
